Pursuant to Section 7(e) of the Illinois Open Meetings Act, the Board of Trustees will conduct its **Regular Board Meeting** remotely by audio or video conference given the Governor's Disaster Proclamation issued on August 20, 2021 relating to public health concerns because of the COVID-19 disaster and wherein all or a part of the District's jurisdiction is covered by the disaster area. The Board President has determined that an in-person meeting is not practical or prudent based on localized conditions in the District's jurisdiction and because of the disaster, including that current available data show that the percentage of fully vaccinated District residents is lower than average vaccination rates, increased percent change in confirmed cases in the past 14 days in the District's jurisdictional boundaries, and community transmission is at high in the District's county; that the District has a high percentage of residents who are essential workers performing the type of work that makes them most vulnerable to the spread of COVID-19; that CCPH recently revised its mitigation guidance to require masking when indoor in a public place, regardless of vaccination status and there is increasing concern over the spread of contagious variants such as the delta variant. At least one member of the public body or the Library Director will be physically present at the meeting location. To help curb the spread of COVID-19, members of the public can join the meeting using the Zoom link below to connect. All persons physically present in the meeting room are required to wear masks.

In lieu of in-person public comments, members of the public may submit written public comments in advance of and during the meeting via email or in the chat option of the Zoom virtual meeting to the Library Director at xmenzies@harvey.lib.il.us. All public comments will be read aloud by the Library Director during the public comment portion of the remote meeting as designated on this Agenda.
